# DAVID ANDERSON SAFARIS TERMS & CONDITIONS

## INDEPENDENT SUPPLIERS

Luxury Adventures, Ltd. d.b.a: David Anderson Safaris designs, plans and makes the travel arrangements for your trip. David Anderson Safaris purchases transportation, hotel accommodations, restaurant and other services from various independent suppliers, who are not affiliated with David Anderson Safaris in any way. Although it chooses the best suppliers available, David Anderson Safaris has no right to control their operations and CANNOT, THEREFORE, BE LIABLE FOR ANY PERSONAL INJURY OR PROPERTY DAMAGE which may occur due to (1) wrongful, negligent or arbitrary acts of omissions on the part of a supplier, its employees and others not under the direct control of David Anderson Safaris or (2) defects or failures of any aircraft, vessel, automotive vehicle or other equipment or instrumentality under the control of independent suppliers.

## SAFARI PAYMENTS

Final payment for your safari is due no later than 75 days before the beginning of the safari. Final payment moneys are held in a client trust account and are used to pay independent suppliers for your safari.

## LODGES, HOTELS AND TENTED CAMPS

David Anderson Safaris or its independent suppliers may find it necessary to make substitutions in the accommodations due to circumstances beyond the control of the company. Normally substitutions are of superior or equal quality. If a substitution of equal or superior quality cannot be secured, tour members will receive a refund for the difference.

## AIRLINES

David Anderson Safaris has no control over any airline operations. Airline delays and extra expenses incurred because of airline delays or missed flights are not the responsibility of David Anderson Safaris. David Anderson Safaris is not a travel agency and therefore cannot sell air tickets.

## REALITIES OF TRAVEL IN THIRD WORLD COUNTRIES

Africa does have its primitive and rustic side. David Anderson Safaris is not responsible for the cleanliness of rest rooms, delays in immigration and customs, occasional equipment breakdowns, and other "third world country adventures" while you are in Africa.

## OPTIONAL ACTIVITIES THAT MAY BE DANGEROUS

At some of the places you will visit on your tour, optional activities will be furnished by other independent suppliers who are not affiliated with David Anderson Safaris in any way. Some of these activities carry with them various inherent risks, including that of attack by wild animals, which can cause serious personal injury. These activities include, but are not limited to: (a) walking safaris; (b) horseback safaris; (c) camel safaris; (d) canoe trips; (e) hot air balloon trips; (f) Lake Victoria fishing village; (g) Maasai village, (h) gorilla and chimpanzee trekking on foot and (i) elephant back safaris, (j) white water rafting, (k) bungee jumping. You should be aware that, although precautions are taken by the suppliers to guard against such dangers, your safety cannot be guaranteed. Should you elect to participate in such activities while you are on your tour, you are, of course, free to do so. However, you must understand that such participation will be at your own risk, and that David Anderson Safaris can assume no responsibility for your safety.

David Anderson Safaris requests common sense and caution be exercised while visiting any of the cities and towns on the tour. David Anderson Safaris is in no way responsible for incidents or personal or public interaction occurring between a tour member and anyone you may meet in Africa.

## ACTS OF GOD AND THE LIKE

David Anderson Safaris is not liable for acts of God, fire, weather, global warming, climate change, acts of governments or other authorities, wars, civil disturbances, riots, terrorist acts, strikes, thefts, pilferage, epidemics, quarantines, dangers incident to sea, land and air travel, and other similar acts or incidents beyond its ability to control.

## CANCELLATION AND REFUNDS

All cancellations must be made in writing to David Anderson Safaris. **Cancellation of your safari after 15 August 2010 will result in the loss of your deposit.** After 90-days prior to your departure, cancellation fees are as follows:

89-60 days	30% of tour price
59-45 days	40% of tour price
44-30 days	60% of tour price
after 30 days	100% of tour price

Trip cancellation insurance is recommended. There is no refund should you leave the safari early for any reason and no refund for any unused services.

## SINGLE ROOM SUPPLEMENT

The price of this tour is based on two people sharing a room. If a single room is required, or a suitable roommate is not available, you will be responsible to pay the single room supplement. If you are forced to share for any part of this safari, you will receive a refund for those nights.

## SAFARI MEMBERS

The tour operator assumes no responsibility for the attitudes or personalities of tour members. Those with serious health problems, physical or mental, are asked not to book a safari with David Anderson Safaris.

## TRAVELER'S REPRESENTATIONS

- I certify that I have not recently been treated for, nor am I aware of, any physical or other condition or disability that would create a hazard to myself or other members of this tour.
- I understand that acceptance of the Terms and Conditions covering this tour and payment thereof is an acceptance by me of the tour conditions applicable to the tour.
- I understand that David Anderson Safaris reserves the right to adjust U.S. Dollar prices, without notice, to reflect fluctuations in the Foreign Exchange Markets David Anderson Safaris has no control over taxes or special assessments which may be imposed by African Governments or airlines.
- I understand that David Anderson Safaris reserves the right to withdraw a tour or any part of it, to make such alterations in the itinerary and/or hotel accommodations as seems necessary or desirable, to refuse to accept or retain as a member of the tour any person at any time, and to pass on to tour members any expenditures occasioned by delays or events beyond its control (In case of an appreciable variation in cost in these, the right is reserved to make such adjustments to rates as necessary.).
